



FISCAL SUMMARY

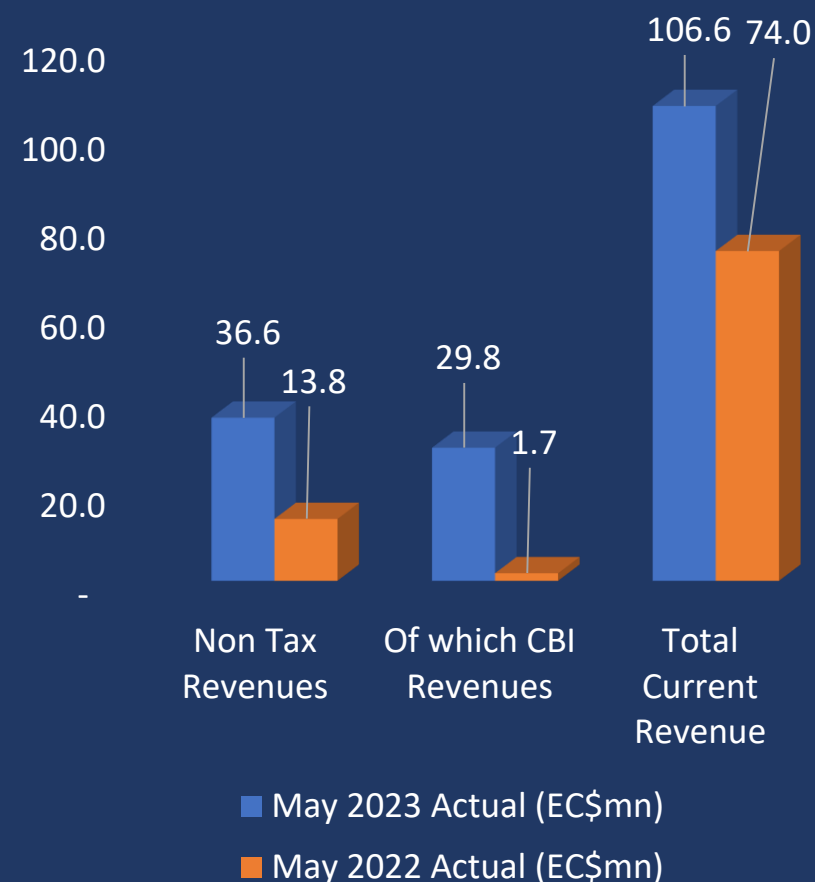
May 2023

1. Current Revenue for May 2023 was \$106.6m, which was \$18.8m more than the 2023 target and \$32.6m more than the collections for May 2022.
2. Total Grants in May 2023 amounted to \$1.4m which was \$3.7m less than the target and \$12.5m less than the actual in May 2022.
3. Total Current Expenditure, excluding principal repayments for the month of May was \$65.2m, which was \$3.3m less than the \$68.5m targeted.
4. Capital Expenditure in May 2023 was \$15.6m, \$20.5m less than the amount spent in May 2022 and below the \$23.5m targeted for the month this year.
5. A primary balance (including grants) of \$37.0m was recorded for the month of May 2023, which was \$26.7m more than the month's target and \$33.6m more than the amount recorded in May 2022.
6. Principal Repayments on Debt for May 2023 was \$17.4m, while interest payments totaled \$9.8m.

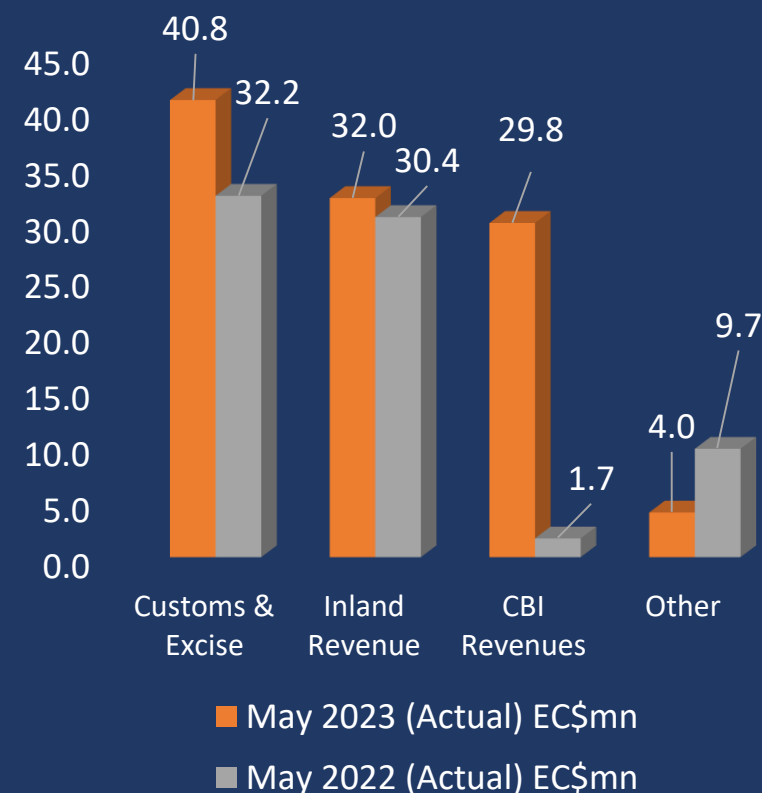
CBI Revenues which were recorded as Grants as of 2022 is now recorded as nontax revenue hence the variance in comparison to 2022.

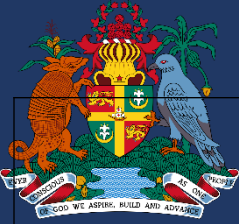
