

# FISCAL SUMMARY April 2017

- 1. Current Revenue for April 2017 was \$52.5M, which was \$3.4M below the target and \$0.2m less than the collections for April 2016.
- 2. Grants received in April 2017 amounted to \$7.3M, which was \$4.9M below the targeted \$12.2M.
- 3. Total expenditure for the month of April was \$58.7M, \$1.5M below the targeted \$60.2M.
- 4. A primary surplus after grants of \$4.3M was realized for the month of April 2017.
