

FISCAL SUMMARY January 2023

- 1. Current Revenue for January 2023 was \$87.3m, which was \$4.0m more than the 2023 target and \$0.4m less than the collections for January 2022.
- 2. Total Grants in January 2023 amounted to \$1.0m which was \$2.3m less than the target and \$4.9m less than the actual in January 2022.
- 3. Total Current Expenditure, excluding principal repayments for the month of January was \$48.6m, which was \$7.2m less than the \$55.8m targeted.
- 3. Capital Expenditure in January 2023 was \$15.6m, \$2.1m less than the amount spent in January 2022 and below the \$15.3m targeted for the month this year.
- 4. A primary balance (including grants) of \$26.8m was recorded for the month of January 2023, which was \$8.7m more than the month's target and \$4.7m less than the amount recorded in January 2022.
- 5. Principal Repayments on Debt for January 2023 was \$22.2m, while interest payments totaled \$2.8m.

Exceptional Revenue - Revenue that is not part of the regular collections but has a significant impact for the relevant period.

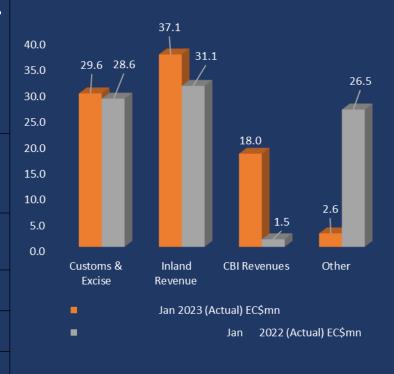
CBI Revenues which were recorded as Grants as of 2022 is now recorded as nontax revenue hence the variance in comparison to 2022.
