



FISCAL SUMMARY

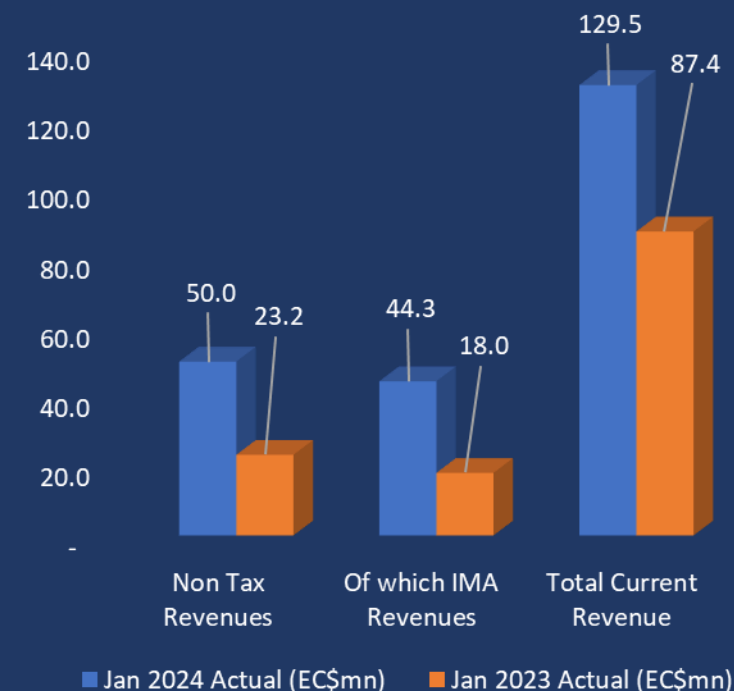
January 2024

1. Current Revenue for January 2024 was \$129.5m, which was \$18.1m more than the 2024 target and \$42.1m more than the collections for January 2023.
2. Total Grants in January 2024 amounted to \$0.4m which was \$4.7m less than the target and \$0.6m less than the actual in January 2023.
3. Total Current Expenditure, excluding total Principal Repayments for the month of January was \$71.4m, which was only \$0.5m more than the \$70.9m targeted.
4. Capital Expenditure in January 2024 was \$9.7m, \$5.9m less than the amount spent in January 2023 and below the \$20.4m targeted for the month this year.
5. A Primary Balance (including Grants) of \$51.4m was recorded for the month of January 2024, which was \$24.0m more than the month's target and \$24.5m more than the amount recorded in January 2023.
6. Total Principal Payments on Debt for January 2024 was \$6.8m, while Interest Payments totaled \$2.6m.

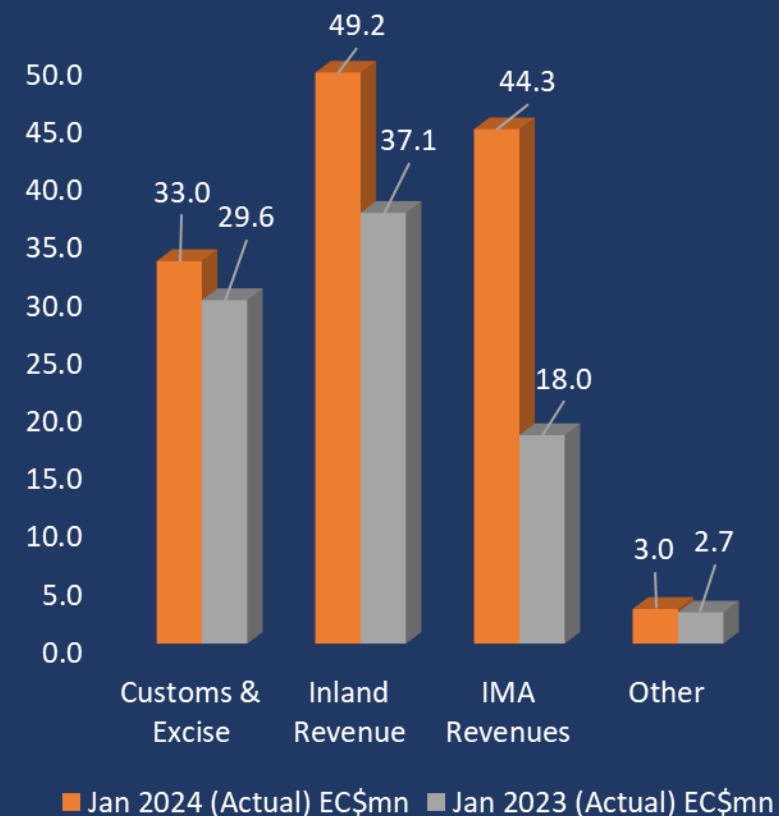

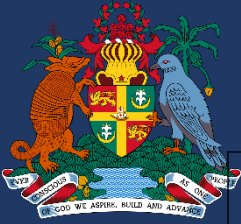
