

OVERVIEW January 2025

- 1. Revenue Performance: In January 2025, current revenue underperformed relative to projections, driven by shortfalls in non-tax miscellaneous receipts. Grant inflows also fell below target.
- 2. Expenditure Trends: Current expenditures remained below programmed levels, while capital outlays exceeded targets, indicating robust implementation capacity.
- 3. Fiscal Balance: The primary and overall fiscal surpluses stood at \$14.8 million and \$12.2 million, respectively, both surpassing monthly benchmarks.





FISCAL SUMMARY January 2025

- 1. Current Revenue for January 2025 was \$102.6m, which was \$1.9m less than the 2024 target and \$26.9m less than the collections for January 2024.
- 2. Total Grants in January 2025 amounted to \$0.7m which was \$3.2m less than the target and \$0.3m more than the actual in January 2024.
- 3. Total Current Expenditure, excluding total Principal Repayments for the month of January was \$59.3m, which was \$18.8m less than the \$78.1m targeted.
- 4. Capital Expenditure in January 2025 was \$31.8m, \$22.1m more than the amount spent in January 2024 and above the \$23.3m targeted for the month this year.
- 5. A Primary Balance (including Grants) of \$14.8m was recorded for the month of January 2025, which was \$5.5m more than the month's target but \$36.6m less than the amount recorded in January 2024.
- 6. Total Principal Payments on Debt for January 2025 was \$6.8m, while Interest Payments totaled \$2.6m.
